4. Health Benefits Update for 2023-2024

Lin Miller talked about the benefit changes for 2023-2024. Marsh & McLennan negotiated renewal rates for all medical plans at 8%. There are no plan changes, but there are some small additional benefits for Blue Shield medical plans, and no medical plans will have any decrements. The flexible spending account maximum increased to \$3,050 for the 2023-2024 year with a carryover of \$610.

Dr. Mims reported that our enrollment at Job Corps is increasing. The Independent Study school year will begin on August 31st. Sites are hosting orientations over the summer, resulting in new enrollments for Job Corps and I.S. sites. We continue to work closely with I.S. sites to support prospective student outreach and pre-enrollment.

b. RAPSA

Dr. Mims talked about the establishment of the Reaching At-Promise Students Association (RAPSA) over 10 years ago. This organization provides professional development for practitioners working with at-promise students and serves as a nationwide policy forum for education policymakers. Dr. Mims will be working to ensure SIATech and RAPSA can chart their organizational paths forward with clarity and purpose.

c. SIATech Summit

Stacey Wilkins shared an overview of the SIATech Summit taking place August 23-24, 2023, at the Rancho Bernardo Education Center. The all-staff in-person conference will focus on teaching and learning and include general and breakout sessions tailored to specific audiences including certificated staff, principals/site leaders, ITAs and admin clerical, I.S., and Job Corps staff.
