MINUTES

I. CALL TO ORDER/WELCOME GUESTS

Board Chair Herrity called the meeting to order at 5:43 p.m. The Chair recognized a quorum. In-person board members were Terrance Mims, Elyse Burden, Jennifer Credit, Erica Alfaro, and Asha' Jones (who arrived at 5:59 p.m.). Joe Herrity and Oliver Unaka participated virtually. Central office staff joined in person.

5. Budget Update

During the report, Tom Renner mentioned that SIATech had an overall revenue-over-expense deficit of -\$2,983,371, and SIATech Academy South had a deficit of -\$111,660. The deficit is due to funding based on P2 ADA of 710.79 for SIATech and 108.09 for SAS. Based on P2 for this school year (SIATech 950.04 / SAS 120.95), the funding is expected to true up at the end of February.

The audit report for the fiscal year 2022-2023 has been completed and submitted to the California Department of Education (CDE). The audit report is unmodified, which means that there are no concerns or adverse items to report. However, an audit finding was noted regarding a discrepancy in the number of months included in ADA calculations at P2. This

discrepancy increased our ADA from 710.79 to 714.16, which resulted in an understatement of receivables. We have implemented corrective measures. Auditors will review the 2022-23 audit at the February board meeting.

V. EDUCATION SERVICES

6. Multi-Tiered System of Supports (MTSS) Framework

Stacey Wilkins provided an overview of the SIATech Way Roadmap, which is a comprehensive system of support consisting of five stages. These stages are records evaluation, establishing connections (fostering relationships and defining the mentor's role), ILP advisory process (collaboratively creating the plan and setting goals), mentor guidance (providing assistance and services), and finally, transition planning (preparing for college and career).
