V. REPORTS TO THE BOARD

- 5. Superintendent's Report
 - a. EL Update
 - SIATech's new ELL Coordinator, Ms. Ayala, has started working along with the ELL Committee to improve our ELL program and services. She has started visiting school sites to meet with teachers.
 - The ELL Committee has identified three English language development programs and is in the process of scheduling demos as part of the ELL curriculum review.

- The ELD professional development series on English Language Development for staff is underway.
- Ms. Ayala is also working with the School Leadership Teams to set up an
 English Language Advisory Committee (ELAC). The ELAC will help our parents
 and the community we serve to learn more about SIATech and the
 educational opportunities we have to offer.

b. Enrollment Update

The second attendance reporting period (P2) has concluded in which neither SIATech's or SIATech Academy South's Average Daily Attendance (ADA) improved due to the Covid Omicron variant that further impacted our school sites, particularly at Job Corps locations.

c. Budget Development

The CDE is reporting how the pandemic has affected enrollment in all schools across the state with a 2.6% drop realized in FY 2020-21 and a 1.8% continued drop this year; our enrollment loss is more acute at 55.1%. Lawmakers and the governor recognize this in which legislation is being considered to provide relief in the upcoming year in the form of a hold/harmless on ADA for one year utilizing the ADA from FY 19-20. Enrollment target levels for both Job Corps and IS have sites have been established.

As we head into the next budget cycle, these are three possible scenarios for SY 2022-23:

- Hold Harmless Scenario: Utilizing FY 2019-20 ADA data = 1121 ADA
- Partial Recovery Scenario: Representing 69% ADA recovery
- Slight Recovery Scenario: Representing 4% ADA recovery

We will move forward and engage with NEWCorp to obtain a signed promissory note for the debt repayment to SIATech.

The committee will review the draft then forward to the entire Board for input. The evaluation draft will be completed at the May board meeting and presented during the June meeting, in closed session.
